- 3) That, there are 17 members in the said school managing committee, details as given below and they are not either closely or distantly related to each other.

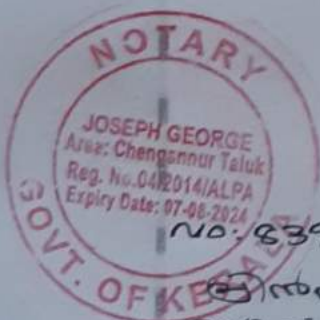
